
Sir,

- Handing over the management of Nine Thermal Power Stations to the Private 1) Management.
- Privatization o the most profitable Distribution Companies namely Islamabad ii) and Faisalabad.
- Out sourcing Billing of Elecy. Consumers. iii)

- That, the union held mass Protest on 1st November, 2011 all over the country. As a result of that, the President of Pakistan'decided to with-held the said decision and assured that the decision would not be made without consulting the Stake Holders.
- Despite this, the Government has been persuing the Policy of Privatization of Elecy. and has disbanded Pakistan Electric Power Company and has been outsourcing the management of nine National Thermal Power Station

- That, the union has filed a Writ Petition in Sind High Court under Article 199 of the Constitution of Pakistan of the Constitution to challenge the disbanding of unified Elecy. System under Pakistan Electric Power Company which has been admitted for hearing.

In such circumstances, we request your goodself that you may kindly use your office to write to Managing Director, IMF and the President World Bank that they may incorporate the policy of Consultation with the Stake Holder namely our representatives National Industry-wise this 0Trade Union pressing the Government not to persue de-Regulation of the National Elecy. Public Utility. Since it will not only create Inter Provincial Dispute on differential Power Tariff alike existing dispute on Water Distribution, but also it will create chaos alike the bitter experience of Privatization of Karachi Electric Supply Company. It will be also against the public interest.
