TIME ZONE	At the time of the meetings, the time in Port of Spain is:			
	 same time as in the Eastern Caribbean, Dutch Caribbean, Haïti, and the USA; one hour behind the time in Bermuda; one hour ahead of the time in Jamaica; two hours ahead of the time in Belize 			
CURRENCY	Official currency is the Trinidad & Tobago dollar (TTD). The currency is on a managed float regime, with an exchange rate of approximately USD1.00 = TTD6.63.			
	Visit <u>www.oanda.com</u> for up-to-date rates.			
	In February 2021, the central bank introduced a polymer version of the \$1 and a redesigned polymer \$50 note. The paper-based notes were discontinued on January 1, 2022.			
	Best rate is always at a bank. There are banks, Cambio and ATMs at Piarco International Airport. The Cambio for currency exchange is located immediately after leaving the Immigration Hall.			
	We recommend that you use the official currency (TTD) for your various purchases/financial transactions.			
ELECTRICITY	100 volts, (2 flat pins or 2 flat pins with round ground pin).			
	For those who use 220 volts, please bring your pin adaptors			
	The hotels provide irons and ironing boards in rooms.			
TAXIS	We recommend that you organise taxis through the front desk.			
HEALTH & SAFETY	Please check with your health authorities to confirm COVID-19 exit and entry requirements for travelers.			
	There is no longer the mandatory wearing of masks in Trinidad & Tobago, with the exception of public health facilities and other institutions. However, please note that this may vary from business to business. Please inquire in advance.			
EATING OPTIONS	If you are not interested in having dinner at the hotel, there are many options available near the Normandie and the Kapok hotels.			
	There is also a mini mart a major supermarket up the road from the Normandie. Ariapita Avenue with its street food is also nearby.
